## A BILL

To amend the Animal Welfare Act to improve the standards for the care and treatment of certain animals, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Puppy Protection Act  
5 of 2003”.

1 **SEC. 2. BREEDING REQUIREMENTS.**

2 Section 13(a)(2) of the Animal Welfare Act (7 U.S.C.  
3 2143(a)(2)) is amended—

4 (1) in subparagraph (A), by striking “and” at  
5 the end;

6 (2) in subparagraph (B), by striking the period  
7 at the end and inserting “; and”; and

8 (3) by adding at the end the following:

9 “(C) for addressing the initiation and fre-  
10 quency of breeding of female dogs so that a fe-  
11 male dog is not—

12 “(i) bred before the female dog has  
13 reached at least 1 year of age; and

14 “(ii) whelped more frequently than 3  
15 times in any 24-month period.”.

16 **SEC. 3. SUSPENSION OR REVOCATION OF LICENSE, CIVIL**  
17 **PENALTIES, JUDICIAL REVIEW, AND CRIMI-**  
18 **NAL PENALTIES.**

19 Section 19 of the Animal Welfare Act (7 U.S.C.  
20 2149) is amended—

21 (1) by striking “SEC. 19. (a) If the Secretary”  
22 and inserting the following:

23 **“SEC. 19. SUSPENSION OR REVOCATION OF LICENSE, CIVIL**  
24 **PENALTIES, JUDICIAL REVIEW, AND CRIMI-**  
25 **NAL PENALTIES.**

26 “(a) SUSPENSION OR REVOCATION OF LICENSE.—

1 “(1) IN GENERAL.—If the Secretary”;

2 (2) in subsection (a)—

3 (A) in paragraph (1) (as designated by  
4 paragraph (1)), by striking “if such violation”  
5 and all that follows and inserting “if the Sec-  
6 retary determines that 1 or more violations  
7 have occurred.”; and

8 (B) by adding at the end the following:

9 “(2) EFFECT OF MULTIPLE SERIOUS VIOLA-  
10 TIONS.—If the Secretary finds that any person li-  
11 censed as a dealer, exhibitor, or operator of an auc-  
12 tion sale subject to section 12 has committed a seri-  
13 ous violation (as determined by the Secretary) of  
14 any rule, regulation, or standard governing the hu-  
15 mane handling, transportation, veterinary care,  
16 housing, breeding, feeding, watering, or other hu-  
17 mane treatment of dogs under section 12 or 13 on  
18 3 or more separate inspections within any 8-year pe-  
19 riod, the Secretary shall—

20 “(A) suspend the license of the person; and

21 “(B) after providing notice and a hearing  
22 not more than 30 days after the third violation  
23 is noted on an inspection report, revoke the li-  
24 cense of the person unless the Secretary makes  
25 a written finding that revocation is unwar-

1 ranted because of extraordinary extenuating cir-  
2 cumstances.”;

3 (3) in subsection (b), by striking “(b) Any deal-  
4 er” and inserting “(b) CIVIL PENALTIES.—Any  
5 dealer”;

6 (4) in subsection (c), by striking “(c) Any deal-  
7 er” and inserting “(c) JUDICIAL REVIEW.—Any  
8 dealer”; and

9 (5) in subsection (d), by striking “(d) Any deal-  
10 er” and inserting “(d) CRIMINAL PENALTIES.—Any  
11 dealer”.

12 **SEC. 4. REGULATIONS.**

13 Not later than 1 year after the date of enactment  
14 of this Act, the Secretary of Agriculture shall promulgate  
15 such regulations as are necessary to carry out the amend-  
16 ments made by this Act.
